The Bankers Institute of Rural Development, Lucknow invites applications for empanelment of Contractors for the following proposed works

(1) Chemical Water Proofing, (2) Toilet Water Proofing and (3) Plumbing & Sanitary Works at BIRD Complex.

The estimated cost of the work is Rs. 33 Lakhs (to be done in phases). The work in each phase will be costing approximately Rs. 5 Lakhs. Minimum criteria for empanelment is indicated below.

1. Average Annual financial turnover during the last 3 years, ending 31st March 2009, should be at least 1.5 Lakhs of the estimated cost.
2. Experience of having successfully completed similar works during last 7 years ending December 2009 as per following details :
 - a. Three similar completed works costing not less than the the amount equal to 2 Lakhs.
 - OR
 - b. Two similar completed works costing not less than the amount equal to 2.5 Lakhs.
 - OR
 - c. One similar completed work costing not less than the amount equal to 4 Lakhs.

Intending applicants are required to submit their full bio-data giving details about their organization, experience, technical personnel in their organization, spare capacity, competence and adequate evidence of their financial standing, etc. in the enclosed statement which will be kept confidential.
3. While deciding upon the selection of contractors emphasis will be given on the ability and competence of applicants to do good quality works within the specified time schedule and in close co-ordination with other agencies, besides the rate structure of the items.
4. Decision of the BIRD in regard to selection of contractors for issue of tender forms will be final. The Bank is not bound to assign any reason thereof.
5. Each page of the application shall be signed. The application shall be signed by person/persons on behalf of the organization having necessary authorization/Power of Attorney to do so.
6. If the space in the proforma is insufficient for furnishing full details, the information shall be supplemented on separate sheets of paper stating therein the part of the statement and serial number. Separate sheets shall be used for each part.
7. Any letter or document accompanying the pre-tender qualification form shall be submitted in duplicate.
8. Applications containing false and/or inadequate information are liable for rejection.
9. While filling up the application with regard to the list of important projects completed or on hand, the applicants shall only include those works which individually cost not less than Rs. One lakh.
